4. BUSINESS ITEMS

4.1 Review of COVID-19 Emergency Operations Centre Situation Response

Kelly Stienwand, Director of Emergency Management, provided a verbal update on the COVID-19 Emergency Operations Centre including current provincial and municipal statistics, review of the use and continued development of the critical and vital services dashboard and predictive modelling tools.

The Director stated that Town flood action plans are being reviewed to ensure COVID-19 compliance should flooding occur this spring.

The Director provided information on positive initiatives being undertaken in the community such as the fire and protective services teams joining forces to do "birthday drive-by's" for local children while they are in isolation.

4.2 Declaration of Vital Services

Elaine Vincent, Chief Administrative Officer, reviewed the report containing the issue that Council acts as the Emergency Advisory Committee (EAC) in alignment with Bylaw 42-18. The EAC is required to make recommendations to Council on the development of additional programs to support the COVID-19 pandemic.

4.2.1 Emergency Social Services Strategies

Susan Laurin, Community Services Director, reviewed the report containing an update on Emergency Social Services (ESS) activities and plans to support residents through the COVID-19 event. Debbie Posey, Community Wellness Manager, was present and assisted in answering questions from the Committee including the process for residents to access the daily check-in program, and the use of social media messaging and story sharing initiatives to empower residents in supporting each other.

4.2.2 Economic and Business Recovery Strategies

Angela Groeneveld, Economic Development Manager, provided information on strategies for economic and business recovery. The Manager answered questions from the Committee including the 'stronger together' logo, the one-stop shop for business recovery supports, and ways for residents to support local businesses during the COVID-19 crisis.

MOTION: By Councillor Rockley that the Emergency Advisory Committee recommend to Council the inclusion of 'social fabric' and 'business retention' as vital services under the Community Emergency Management Plan, business continuity plans, and that the strategies and budgets for these plans be presented to Council at the April 27, 2020 Regular Meeting.
