Provide recommendations regarding the deep utility replacement project to Town of Okotoks based on an informed, strategic discussion.

## Deep Utility Replacement Project

#### Goal 1

Complete upgraded to infrastructure that was installed in the 1950's and lifecycle replacement is required.

#### What if we don't upgrade:

- It's inevitable that the infrastructure will be upgraded.
- There have been several water main leaks and breaks in recent years leading to unplanned outages and water losses.

Replacement of the deep utilities in the remainder of downtown occurred as part of previous vitalization phases as noted below and are complete.

Phase 1 (2001) – Elizabeth Street from Northridge Drive to Elk Street

Phase 2 (2002) – Elizabeth Street from Elk Street to Veterans Way

Phase 3 (2007) – McRae Street from Veterans Way to McRae Street

### Goal 2

Accelerate the timeline to complete majority of work with the consideration that this time might have the least impact to the downtown business community.

#### Why now?

- Events are cancelled downtown.
- Many businesses are closed.
- Contractors have capacity to complete work in an accelerated fashion and at a lower cost to taxpayers.

### Goal 3

Engage with businesses to best understand the sentiments of the businesses and help to decide on next steps.



## Project Impacts and Mitigations

- 1. Streets for vehicular traffic will be closed. **Detours and temporary traffic controls** will be in place to minimize the impact to traffic.
- 2. Daggett Street and McRae will remain open to local traffic.
- Parking to access businesses will be identified and communicated to the community.
- **4.** Access to each business will be protected. Sidewalks will remain open to all users for the entire duration of construction.
- 5. Prior to the start of each phase, **temporary water service** will be connected to each property by the contractor. Sanitary will remain unaffected by construction.

#### Now vs Later?

#### Why Now

- Window of construction is dependent on the frost in the road
- Can not predict or control leaks/breaks
- Reactive repairing of infrastructure (impact on businesses and costs associated)
- Saving to ratepayers overall
- Contractors are available now can dictate timing better. Encourage aggressive timelines
- Consumer behaviors may have changed and there is hesitation due to social distancing concerns.
- There is an anticipated slow entry into economic activity.
- Events cancelled creating an opportunity

#### Why Later

- Business owner's desire to get going with opening
- Already an increase in business due to warm weather
- September better time to consider
- Concern about customers' perception of inconvenience
- Need to get some \$ in for the summer and think next June would be better than now
- Even those businesses not directly impacted there is a decrease in traffic in general to the downtown.
- Every customer counts right now.

### Notes

Bylaws changed to allow for patio in back of Homeground during construction?

Parking is an issue however with communication to residents perhaps there would be concessions made.

Timing:

Delay end of August – beginning of September Look at changing order – for less impact (if there is a delay)
