



**Okotoks RCMP
Municipal Policing Report
Q4 – October, November & December 2020**

PERSONS CRIME / DOMESTIC VIOLENCE

The RCMP 4th quarter statistics showed an upward trend for assault calls when compared to the 4th quarter of 2019. The reported assault calls were up by 11 calls for service from 22 in 2019 to 33 in 2020. Positively, reported assaults went down from the 3rd quarter statistics for 2020, where assault calls went from 36 to 33 for the 4th quarter of 2020.

There was a 25% increase in the number of domestic violence related calls for service in the 4th quarter in comparison to the 4th quarter of 2019. The numbers in comparison from the 3rd quarter of 2020 were down slightly by two calls for service. On a 5-year average for the 4th quarter, domestic violence calls were down by 4%.

PROPERTY CRIME

Property crime trended downward 10% compared to this same quarter from last year. We had 150 property related calls for service during the 4th quarter of 2020 in comparison to 167 calls for service in the 4th quarter of 2019. Property Crime calls for service decreased by 40 calls from the 3rd quarter of 2020.

OTHER CRIMINAL CODE

Total other Criminal Code calls for service including; fail to comply with and breach of court orders, weapons offences and disturbing the peace decreased 45% from the 4th quarter of 2019.

TOTAL CRIMINAL CODE

Total Criminal Code calls for service for 2020 dropped 9% in comparison the 4th quarter of 2019.

PROVINCIAL STATUTES / MUNICIPAL BY LAW

Provincial statutes call for service increased 31% in the 4th quarter in comparison to 2019 during the same reporting period. Mental Health and Provincial Health Acts calls for service increased our provincial statute numbers. The total municipal by-law calls for service also increased by 43% for the 4th quarter when compared to 2019 statistics.

MOTOR VEHICLE COLLISIONS

Motor Vehicle Collisions for the 4th quarter showed a decrease of 31% on a 5-year average and were down by 51% compared with this quarter in 2019.
