### **BYLAW 10-23**

# A BYLAW OF THE TOWN OF OKOTOKS IN THE PROVINCE OF ALBERTA TO AMEND FEES, RATES, AND CHARGES BYLAW 09-23

**WHEREAS** pursuant to the provisions of the *Municipal Government Act* (the *Act*), Revised Statutes of Alberta 2000, Chapter M-26 and amendments thereto, the Council of the Town of Okotoks passed Bylaw 09-23, the Fees, Rates, and Charges Bylaw, for the purpose of establishing fees, rates, and charges for services provided by the Municipality; and

**WHEREAS** the Council of the Town of Okotoks deems it desirable to amend Schedule 'A' of Bylaw 09-23 to establish an omitted fee, change the placement of certain charges and penalty, and amend text.

NOW THEREFORE the Council of the Town of Okotoks enacts that:

- 1. Schedule 'A' be amended as follows:
  - 1.1. Under the Operations & Utilities, Cemetery Services category insert the words "After business hours" at the beginning of the Cemetery Service titled "Full Casket Interments Saturday/Sunday/Holiday Funerals and any day after 4 PM (Flat rate in addition to standard open/close charges)"; and
  - Under Operations & Utilities, Parks category, and Community Health & Safety, Facility Rental Rates category replace all instances of 'Sr' with the word 'Senior'; and
  - 1.3. Under Operations & Utilities, delete the Outdoor Playing Field Classification list in its entirety and replace with the following:

1.7. Under the Operations & Utilities, Sanitary Services category delete the following in its entirety:

1.8. Under the Operations & Utilities, Storm Sewer Services category delete the following in its entirety:

1.9. Under the Operations & Utilities, Waste Services category establish the fee of \$25.00 for "Service Charge (for change in service)"; and

1.10. Under the Operations & Utilities, Waste Services category delete the following in its entirety:

Arrears Notice (5 working days after Per occurrence

penalty date)

Transfers to taxes (2 weeks after date of Per occurrence

arrears notice)

Penalty rate on Utilities Receivable in Bi-monthly

arrears : and

1.11. Under Community Health & Safety, Facility Rental Rates category delete all occurrences of the word 'Pason' and replace with the word 'Okotoks'; and

1.12. Under Community Health & Safety, Facility Rental Rates category and Meeting Rooms / Multipurpose Spaces Classification category the full name of each facility will be used followed by the acronym for all first occurrences, and the acronym used thereafter.

# 2. SEVERABILITY

2.1. It is the intention of Council that each separate provision of this Bylaw shall be deemed independent of all other provisions herein and it is the further intention of Council that if any provision of this Bylaw is declared invalid, all other provisions hereof shall remain valid and enforceable

This Bylaw shall come into full force and effect upon third and final reading.
