Growth Management Boards in Alberta

CMRB was formed as a result of the modernized Municipal Government Act (MGA)

Mandatory Growth Management Board in both the Edmonton and Calgary regions

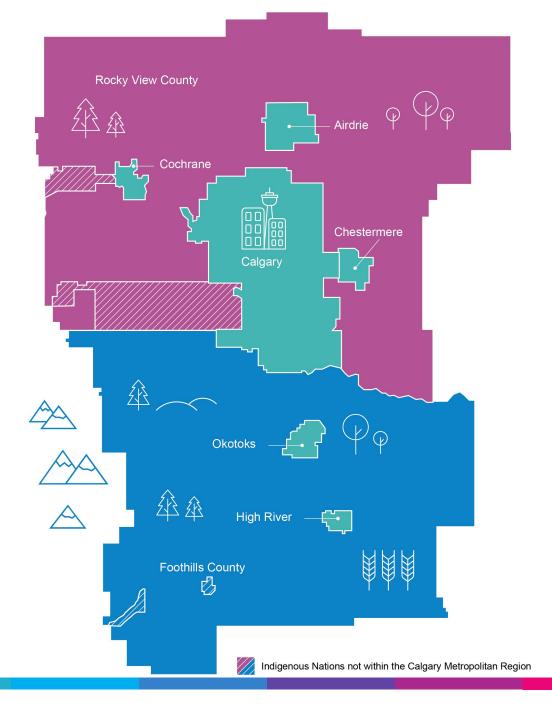
- Established in Section 708.02(1.1) of the MGA
- A growth management board is a government corporation 708.03(1)
- CMRB came into existence on January 1, 2018

Board Mandate

The Calgary Metropolitan Region Board Regulation outlines the Mandate of the Board.

The Board shall

- (a)strive towards consensus regarding matters before the Board,
- (b) promote the long-term sustainability of the Calgary Metropolitan Region,
- (c) ensure environmentally responsible land-use planning, growth management and efficient use of land,
- (d) develop policies regarding the coordination of regional infrastructure investment and service delivery,
- (e) promote the economic well-being and competitiveness of the Calgary Metropolitan Region,
- (f) develop policies outlining how the Board shall engage the public on the growth plan and the servicing plan, and
- (g) be limited in its mandate and role to those powers given to the Board under the Act and this Regulation.

Board Vision



The Benefits of Regional Cooperation

- Increase competitiveness on a global stage
- Attract the next wave of young talent and economic growth
- Save taxpayer dollars through more efficient service delivery
- Reduce land consumption
- Reduce intermunicipal conflicts over time through implementation of a common vision
- Create greater market certainty by identifying preferred locations for growth

Regional Evaluation Framework

- Since August 15, 2022 CMRB Administration has processed eight REF applications
- This included:
 - 5 approved applications
 - 2 withdrawn applications
 - 1 application pending decision

Initiatives

- Digitization of Existing & Approved Land use (DEAL) version 2
 - Update the land use data to help inform multiple future projects
 - Completed June 2023.
- Regional Economic Development Vision and Framework
 - Report completed and approved mid-2023
 - Currently interviewing municipal administrations to
 - Determine Municipal Economic Development efforts across the Region
 - Define 'Tier 1' opportunities
 - Finalize a structure for Collaborate Regional Economic Development

Initiatives

Indigenous Relations

- Ongoing dialogue through organized meetings with Indigenous Nations – maintain momentum
- Demonstrating continued learning about history and experiences through attendance at Indigenous celebrations around the region
- Co-create initiatives (e.g. Additions to Reserve Framework, other)
- Celebrate through partnerships and plan for stories from the land with Indigenous stakeholders
- Stories of the Land pilot project proceeding several potential sites have been identified

Initiatives

Joint Planning Areas (JPA)

- JPA Terms of Reference have all been filed with the Board and work is progressing in all four areas
- JPA Context Studies must be approved by the Board no later than August 15, 2025

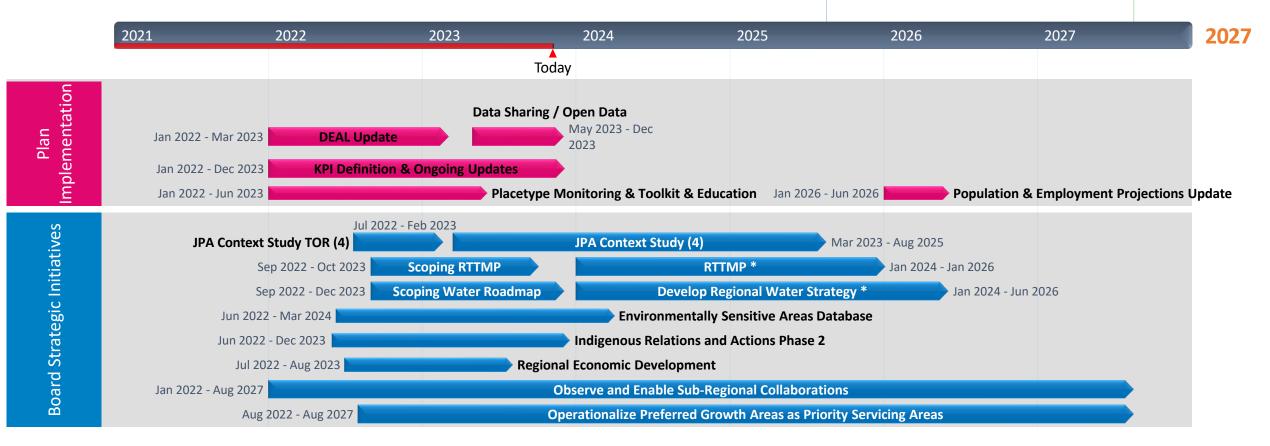
Environmentally Sensitive Areas

- Implementation Framework for ESA policies in GP
- Regional ESA database v1 (ESRI)
- Identify data gaps and recommend strategies to fill gaps such as through ESA studies completed for ASPs/ARPs
- Recommend planning and mitigation strategies to fulfill the Board's Vision and the CMR Growth Plan
- Targeting completion in Q1, 2024

Growth Management Approach

- Preferred Placetypes must be in Preferred Growth Areas
- Proportion of Preferred Placetypes must be identified in Municipal Development Plans:

90% in City of Calgary

75% in other Urban Municipalities

60% in Hamlet Growth Areas

- Employment Areas may be located outside preferred growth areas if approved by the Board (example: Springbank Airport)
- Minister added a Rural Employment Area placeytpe for smaller, lower service employment areas outside Preferred Growth Areas

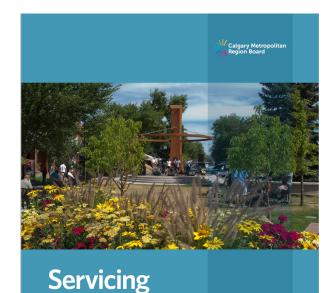

REF Decision Appeal Process

REF DECISION APPEAL PROCESS



Facilitated Discussion

- Dispute Resolution Committee with TOR
- Facilitator from list approved by Board from time to time
- · Board pay costs of facilitator, and any other costs incurred by the Board
- If no resolution, Stage 2

Mediation

- Dispute Resolution Committee with TOR
- Mediator appointed by administration from a roster of mediators approved by the Board
- The parties will share the cost of the mediator. and pay own costs of mediation process
- If no resolution, Stage 3

Land and Property Rights Tribunal

- Conduct a written hearing with three panellists, similar to a 'reference' in the courts
- · Target of issuing a binding decision within 120 days
