Storify Therapy Services offer behavioural activation group therapy (BAGT), a comprehensive program that combines education, training, group sessions and direct clinical care for clients. Collaborating with McMan Youth, Family & Community Services Association, it aims to provide not only mental health skill development but also an activation component allowing participants to apply their learned skills in a supportive community environment providing significant benefits to youth. Skills learnt empower youth to navigate challenges, cope with stressors, and maintain positive well-being. Participation in these groups increases social support. Groups promote prevention and resilience, equip youth with the necessary skills to foster a sense of community. FCSS funding will be used to support staff salaries and programming expenses.

Marianne Dickson, Wild Rose Community Connections Executive Director, presented the organization's 2024 funding request of \$27,248.00

DadConnexx Program builds capacity for Dads and other positive, influential males in a child's life, by providing education on parenting and connecting families to meaningful community resources. Monthly events bring male caregivers and their children together to build relationships, memories and parenting skills, outreach is provided for individualized supports to promote positive parenting, social events that include the whole family to further strengthen relationships and support networks, and learning opportunities are provided.
