Councillor Lang provided an inquiry regarding the possible start date of street sweeping.

Chief Administrative Officer Elaine Vincent provided a response that, weather pending, crews typically begin street sweeping the last week of March.

Councillor Heemeryck provided information that the order of street sweeping is determined on a rotational basis annually, and inquired if this was accurate Chief Administrative Officer Elaine Vincent provided a response that if a zone was first in the street sweeping order last year they would be last in the rotation this year and the second zone would move to being first on the list, and so on. The same rotation is done for both street sweeping and snow removal.

Mayor Thorn provided an inquiry on an update regarding the illumination of the gateway signs.

Chief Administrative Officer Elaine Vincent provided a response that this is now a legal matter and Administration is expecting the signs to be fully functional by March 31, 2024.

Mayor Thorn requested data regarding the one-week, pre-registration timeframe for Town programs that is dedicated for Town and Foothills County residents.
