## **KEY UPDATES**

- **Violation Trends:** Speeding remains the top violation type, with approximately 35% of tickets, tags, and written warnings issued for speeding infractions.
- **Complaint Analysis:** Traffic-related complaints remain the top complaint type, with approximately 38%. Notably, parking related violations are the most prevalent subcategory within traffic related complaints.
- **Operational Activity:** A significant increase of 146% in patrol activity is observed this quarter vs the same period last year. This heightened presence underscores OME's commitment to proactive policing and community safety.
- **Efficiency Enhancements:** The implementation of the Set Summary form has allowed for streamlining proactive activities at the end of each set of shifts.
- **Community Engagement:** An important achievement was efficient collaboration on the successful execution of the 2024 Public Safety Survey to identify public safety priorities for both RCMP and Municipal Enforcement.

These key updates signify OME's dedication to addressing prevalent issues, improving operational capabilities and fostering meaningful engagement with the community to support public safety.
