

Dear Town Council Members,

As residents of D'Arcy, my wife Sherry and I are writing to introduce a petition to oppose Bylaw 27-24 to amend the Land Use Bylaw 17-21 by redesignating the 4.10 acers of land comprising Lot 3, Block 9, Plan 181 0640 from Agricultural and land Holdings District (ALC) to Neighbourhood Core (NC) District.

The attached petition, which has garnered support from 120+ residents in just six days outlines our concerns.

Of the 120+ D'Arcy residents we spoke with, 95% disagree with the proposed re-zoning. The remaining 5% were divided between supporting it or needing more time to decide. It seems reasonable to conclude these percentages accurately reflect the opinion of the community. We understand the small community garden will remain regardless of this re-zoning, however, rezoning the entire parcel Recreation & Open Spaces District (ROS) would be far more desirable and address these concers.


Additional themes emerging from discussions with residents include:

- concerns over traffic congestion in and out of D'Arcy and the related increased safety risks of exiting in the event of a fire or disaster
- addition strain on the Town's limited water supply
- many seniors who purchased homes feel they were mislead regarding the future of the community. This includes the north side of Iris Crescent where some were told similar structures would be built behind them where the 3 story rentals units are under construction. Some claim they don't have the energy or resources to move again.



Petition Title: Opposition to Re-Zoning Proposal for Bylaw 27-24: Lot 3, Block 9, Plan 1810640

Introduction: We, the undersigned residents of D'Arcy Okotoks, are writing to express our strong opposition to the proposed re-zoning of Lot 3, Block 9, Plan 1810640, which is currently designated as Agriculture and Land Holdings District (ALH) to Neighborhood Core (NC) District.

Bylaw 27-24 - The Purpose of Bylaw 27-24 is to amend the Land Use Bylaw 17-21 by by redesignating approximately 1.66 hectares (4.10 acres) of land comprising Lot 3, Block 9, Plan 181 0640 from Agriculture and Land Holdings District (ALH) to Neighbourhood Core (NC) District.



Reasons for Opposition:

1. Negative Impact on Residential Character

The proposed re-zoning will alter the character and appearance of our neighborhood. As per the website https://darcyokotoks.com/community, our community boasts "Open spaces and parks are the heart of D'ARCY's naturally active lifestyle that residents value". The screenshot below taken from the website late in July 2024 clearly shows that the agricultural land proposed for re-zoning as "community gardens":



Replacing this community garden with a 70 unit condominium complex will undoubtedly negatively impact the adjacent property curb appeal and values. It will also increase an already very high density residential population! If this land was planned to be designated as R3, that should have been clearly reflected on the website to avoid deceiving property buyers.

2. Increased Traffic and Safety Concerns

Traffic and parking required to accommodate the nearby future schools and sports fields combined with the following adjacent developments will undoubtably result in 600+ new residents and vehicles resulting in traffic and parking congestion.

- Aspire Developments rental apartment buildings (<u>Town of Okotoks Development Permit</u> 134-20 specifies 185 units). <u>Western Wheel states 150 units</u>.
- Partner's Development Group 112 unit, twelve three story rentals

These two projects alone add between 262 and 297 rental units to the community. Building an additional 70 unit condominium complex will exacerbate these issues. Increased residential traffic poses safety risks, particularly for children and elderly residents who use local sidewalks and crosswalks regularly.

3. Precedent for Future Re-Zoning

Allowing this re-zoning sets a concerning precedent for future development in our area. It could lead to a cascade of similar requests, further eroding the character of our neighborhood and overwhelming our local infrastructure.

Conclusion

For these reasons, we urge the Okotoks Town Council to reject the proposed re-zoning. We believe that preserving the current zoning designation is a crucial proactive step towards mitigating these concerns, maintaining the integrity of our community, and ensuring the well-being of its residents.
