Dear Mayor Thorn,

Please find attached the quarterly Community Policing Report covering the period from October 1<sup>st</sup> to December 31<sup>st</sup>, 2024. This report serves to provide a quarterly snapshot of human resources, financial data, and crime statistics for the Okotoks RCMP Detachment.

In the coming weeks and months, we will be engaging with the community and holding town hall meetings as we have done in the past. This will provide us with an opportunity to interact with the community we serve and hear from them directly about what policing issues or priorities they would like our detachment to focus on. I look forward to attending these meetings to connect with our community and will be providing more details as we organize the town hall meetings.

I also want to inform you of the Real Times Operations Centre (RTOC) that is supporting RCMP detachments across Alberta. In October 2022, RTOC was established to optimize our response to incidents around the province. RTOC involves senior police officers monitoring policing operations in real-time, assessing incident risk, coordinating specialized and expert resources, and managing the response. They provide members on the ground with guidance, direction, and support. It is also used to coordinate the deployment of all RCMP resources – federal, provincial, and municipal, both within Alberta and, if required, nationally. The RTOC facility uses cuttingedge technology to provide real time support during emergency situations to RCMP officers across Alberta and is another measure used to enhance public and police officer safety.

I always remain available to discuss your community-identified priorities and any other ideas you may have that will enhance our service delivery to address the priorities that are important to you. As the Chief of Police for your community, I invite you to contact me should you have any questions or concerns.

### **Community Priorities**

#### **Priority #1:** Traffic - Safety (motor vehicles, roads)

#### **Updates and Comments:**

This Objective and its Initiatives are still on track and performing well. While Violation Tickets are still lower than expected, Impaired Driving enforcement continues to be a concerted effort. 13 impaired drivers were taken off the road this quarter. School zone speed operations were higher than expected and will easily meet its target. Traffic continues to be a focus for Okotoks detachment, as 53 written warnings were issued in addition to the tickets and impaired drivers. Overall, there are no concerns with this Objective and the pro-active work completed at the detachment.

#### Priority #2: Police / Community Relations - Police Visibility

#### **Updates and Comments:**

This Objective and its Initiatives continue to be strong at Okotoks detachment. With the Community Action Unit commencing in Mid October, a surge of proactive visibility is observable in the Initiatives this quarter. Foot patrols, Community Events, and School Visits will all meet or exceed their goals for the fiscal year. The Community Action Unit also brings front line members along with many proactive activities, showing the importance of visibility. This has translated to more frequency of proactive work during the evening and weekend shifts by the front-line members. There are no concerns with this Objective.







#### **Priority #3: Crime Reduction**

#### **Updates and Comments:**

This Objective and its Initiatives are on track for the fiscal year. Offender Management Checks were on pace for the quarter. The Community Action Unit has taken over the management of this Initiative, working with Okotoks Probation and disseminating the information promptly so front-line members have updated intelligence to effectively conduct the compliance checks. Property Checks will meet its target in Q4 with Operation Cold Start in February. Business Visits have nearly met their target with the Community Action Unit conducting many foot patrols in the downtown area and spending times with businesses to listen to any concerns they may have, overall which have been positive. There are no concerns with this Objective.

However, any salary expenditures associated with these employees while on leave is included as an "indirect cost" and billed within the Divisional Administration rate, charged to all contracts.

Police Officers: Of the 25 established positions, 20 officers are currently working. There are two officers on special leave (Medical). One position has two officers assigned to that position and there are three hard vacancies at this time.

As of Q3, the annual plan for Okotoks Municipal Detachment is based on 21 working members.

The financial figures as identified above are in alignment with your Financial Plan for 2024-25.

RCMP will continue to provide your community with monthly enhanced reporting to support ongoing forecast adjustments and potential invoice revisions. This increased reporting will support ongoing management of policing budgets, while also enhancing transparency and engagement with our partners.

Quarter 3 invoicing for the 2024/25 fiscal year have been distributed. As we approach the end of the calendar year, we will continue to work with your Detachment Commander and community to align forecasts with current expenditures and expected costs and to ensure forecasts are as accurate as possible.
